



Belvoir is a registered COVID-Safe business, and our procedures follow strict guidelines set by the NSW State Government and Live Performance Australia.

FEELING UNWELL?

If you or someone in your school group are unable to attend due to COVID related illness, we will credit the cost of the ticket.

CHECK-IN

It is not a requirement to check in at this time.

VACCINATION

We request that all audience above the age of 16 have received at least 2 doses of an authorised COVID-19 vaccine. For the safety of our patrons, we request that you perform a Rapid Antigen Test (RAT) before heading to the theatre if you are not vaccinated.

We do not currently require audiences to show proof of vaccination.

FRESH AIR

Belvoir uses 100% fresh air from outside the theatre, which is then cooled or heated and distributed through the building in our air-conditioning. By using 100% fresh air Belvoir reduces the risk of COVID circulating inside the building.

SANITISE

Hand sanitising stations are installed throughout the building.

REGULAR CLEANING

Belvoir has implemented a more intensive daily cleaning regime at the theatre, and our staff do regular additional cleaning of high-touch surfaces during, before, and after each performance including railings, door handles, lift buttons, toilet and cubicle locks, chair backs and tabletops.

CASHLESS CANDY BAR

The Hal Bar is now cashless and will be open so you can enjoy a refreshing beverage or bite to eat before the show. To help manage queues and seating, bars will cease service ten minutes prior to the performance commencing.

As part of our COVID-safe plan, food and drinks may not be taken into the Upstairs Theatre.

Belvoir will continue to follow the latest NSW Government's COVID-19 advice and requirements to keep you safe.

MASKS

Masks are mandatory in the theatre building, unless you have a medical exemption.

You can raise your mask to eat and drink, but we ask that you please wear your mask covering your nose and mouth at all other times, unless you have a legitimate medical reason.

As part of our COVID-safe plan, food and drinks may not be taken into the Upstairs Theatre.

FOYER SPACES

Foyer spaces will be open one hour before showtime. There is seating in the foyer (50 pax capacity) and in the Downstairs Theatre (20 pax capacity). The capacity of these spaces is strictly limited by the 4 square metre rule. When these spaces are full our staff will kindly ask you to move into the Upstairs Theatre. Please maintain 1.5m social distancing wherever possible. You can head straight into the Upstairs Theatre any time from half an hour before the show.

TICKETS

In order to limit contact we will no longer tear your ticket at the doors to the theatre. Instead your tickets will be scanned upon entry for your group. To save scan time the accompanying teacher can inform the usher of the total number in your group and an usher will point you to your seat.

SEATING CAPACITY

Seating will not be socially distanced inside the auditorium. You may see some empty seats in the auditorium, please don't move to them unless an usher has asked you to move. Please keep in mind, restrictions change and you will be seated in accordance with the NSW Public Health Regulations at the time of the performance. School groups may be seated next to general patrons.
