The following information has been prepared to enable you to distribute your assets as you wish. Please find specific wording on page 2 of this document.

#### HOW TO MAKE A BEQUEST TO COMPANY B LTD (BELVOIR ST THEATRE)

We recommend that you seek professional advice from your solicitor or financial adviser in arranging a bequest to us but we can provide you with starting guidance and are happy to discuss in confidence your intention.

#### There are several ways you can make a bequest to Company B Ltd:

- Give an asset or a specific sum of money to Company B Ltd.
- Make a bequest to Company B Ltd to take effect after the death of your spouse, indicating portion would then revert to Company B Ltd
- Leave a percentage of your estate to Company B Ltd
- Leave a particular item or items such as shares, paintings, property, jewellery or other items of value to Company B Ltd
- Take out a life insurance policy with Company B Ltd nominated as a beneficiary.
- You can specify that the remainder of your estate be given to Company B Ltd after you have made a specific bequest of any sort. You may specify that if any named beneficiary is unable to accept your bequest, an alternative it should be given to Company B Ltd.

• If you have an asset such as a house, a parcel of land or a paid up life insurance policy which you will not need in the future, you can donate it as a tax deductible gift now. This may relieve you of any capital gains tax that might be due upon sale.

### SPECIFIC WORDING TO ASSIST WITH MAKING YOUR WILL

#### For a specified cash gift for general purposes wording should read:

"I GIVE AND BEQUEATH the sum of \_\_\_\_\_\_to COMPANY B LTD (CFN14807, ABN 97 002 866 828) for crediting to the COMPANY B LTD STAY IN THE BLACK THEATRE FOUNDATION ACCOUNT for its general purposes free of all duties and taxes payable upon or in consequence of my death and I declare that the receipt of its Company Secretary or other authorised officer shall be sufficient discharge of my executor's duty."

#### For a specified cash gift to a specific area the wording should read:

"I GIVE AND BEQUEATH the sum of \_\_\_\_\_\_\_to COMPANY B LTD (CFN14807, ABN 97 002 866 828) for crediting to the COMPANY B LTD STAY IN THE BLACK THEATRE FOUNDATION ACCOUNT for the purpose of \_\_\_\_\_\_\_ free of all duties and taxes payable upon or in consequence of my death and I declare that the receipt of its Company Secretary or other authorised officer shall be sufficient discharge of my executor's duty."

#### For a gift of residue, the general wording should read:

"I GIVE AND BEQUEATH the residue of my estate / or \_\_\_\_\_% of the residue of my estate to COMPANY B LTD (CFN14807, ABN 97 002 866 828) for crediting to the COMPANY B LTD STAY IN THE BLACK THEATRE FOUNDATION ACCOUNT for its general purposes free of all duties and taxes payable upon or in consequence of my death and I declare that the receipt of its Company Secretary or other authorised officer shall be sufficient discharge of my executor's duty."

#### For an alternative gift, precede the clause with:

"Should any beneficiary predecease me or refuse to accept the specified gift, then I GIVE AND BEQUEATH that portion of my estate to COMPANY B LTD (CFN14807, ABN 97 002 866 828) for crediting to the COMPANY B LTD STAY IN THE BLACK THEATRE FOUNDATION ACCOUNT for its general purposes free of all duties and taxes payable upon or in consequence of my death and I declare that the receipt of its Company Secretary or other authorised officer shall be sufficient discharge of my executor's duty."
